Executive Summary

The Risk Management Division ("RMD") was established to meet critical needs for public entities in the State of New Mexico. *See* RMD's organic statute, NMSA 1978, §15-7-1 *et seq.*

RMD is responsible for self-insured administration and procurement of insurance to protect the Public Liability Fund (*see* § 41-4-23), the Workers' Compensation Retention Fund (*see* § 15-7-6), and the Public Property Reserve Fund (*see* § 13-5-1). RMD administers the State's group benefits self- insurance plan, providing life, vision, health, dental, and disability and the employee assistance program (EAP) coverage for employees of the state and participating local public bodies (*see* § 10-7B-1 *et seq*). Section 51-1-15 further charges RMD with administering the State Government Unemployment Compensation Reserve Fund and the Local Public Body Unemployment Compensation Reserve Fund. As part of this responsibility, RMD works to limit the cost of excess insurance, so agency risks are truly "self-insured" and rates relate more directly to actual losses incurred.

This report includes Property and Casualty Liability numbers that were not provided to the Legislature since 2020 including all Property and Casualty Liability claim settlements for calendar year 2023.

The Risk Management Division has experienced escalating claim costs due to changes to laws affecting Civil Rights awards, and a global pandemic that adversely affected our employee health benefit fund. We are thoughtfully addressing these issues by considering changes to our agency premium base, increasing loss prevention measures to further assist State agencies, and, utilizing our Alternative Dispute Resolution Bureau as effectively as possible.

Finance Bureau

The Finance Bureau (Bureau) supports all of the Risk Management Division (RMD) by centralizing the Division's financial functions, providing accountability, and ensuring timely processing of financial transactions. The Bureau manages budget

preparation, financial reporting, encumbrances, accounts receivable, accounts payable, and contract administration. The Bureau participated in a reorganization in FY23 resulting in the addition of three positions to the bureau through reclassification of long-term vacancies within GSD.

The Bureau also serves one of RMD's key functions – the administration and tracking of nine enterprise funds. Fund solvency has been an ongoing concern and continues to be for several RMD funds to include the Public Liability and Health Benefits funds. The bureau is responsible for managing legal services, health and life benefits, alternative dispute resolution, worker's compensation and property & casualty contracts and RFP's. The bureau further manages the AR, AP and budget responsibilities for the entire division.

In 2023 accomplishments by the Bureau included being the primary contact and coordinator of the transition of the Employee Benefits Bureau to the newly established Health Care Authority (HCA) of the State of New Mexico. The Bureau provided the FY24 budget to the HCA for their FY 25 submission. The Bureau continues to work with GSD Technology Division on enhancing tools created by application developers to further assist RMD in tracking invoices and payments. It is an active participant in the development of the new Risk Management Information System, Claims Vision that was implemented in FY21.

Alternative Dispute Resolution Bureau

The Alternative Dispute Resolution (ADR) Bureau promotes and offers dispute resolution services that help state and other government agencies access resources to prevent workplace discord. Some of the services offered include mediation and training focused on preventative measures. The Bureau trains ADR Coordinators, certifies new mediators, and provides training for veteran mediators.

In fiscal year 2023 (FY23), the Bureau experienced several new challenges. These challenges included the return to the office for state employees, the retirement of its long-time Bureau Chief, and the need to look at new ways to engage a workforce that had been through a great upheaval during the pandemic. Through the challenges, the Bureau remained focused on the overall goal of serving the employees of the State of New Mexico.

The Bureau is available to all covered risk pool entity's employees at any time to coordinate free mediation services. In FY23, the Bureau received 54 mediation inquiries, 21 mediations were scheduled, 19 mediations were completed (resulting in 4 handwritten agreements and 15 oral agreements), and 2 were cancelled without rescheduling.

Through collaboration with agencies, ADR Coordinators report ADR activities that are documented and tracked through quarterly reports. These reports include any measures taken to prevent workplace conflict, documented participation in training and mediation efforts. In FY23, 34 participants reported their quarterly ADR activities. Those agencies included 9 Schools/Universities, 14 Judicial, 4 Executive, 1 Legislative and 6 Other entities. In FY23, the Bureau trained 7 new ADR Coordinators, one new coordinator is employed by one of the highest loss producing agencies in the state.

The Bureau is designed to provide training, certification, and outreach as part of its mission. Since FY20, the landscape of the Bureau changed forcing it to look at new innovative ways of mediation and training due to the pandemic. The most prominent means to support the mission was to continue conducting online mediations and training where needed. Online services set the tone for overall engagement of state employees as they slowly shifted from a remote work setting to an in-office work.

In FY23, the Bureau prepared for the transition of returning to the office by offering three in-person training courses in addition online mediations continued through FY23. The Bureau conducted 43 training events that reached 1,572 attendees in 66 state agencies. The Bureau also launched a 15-hour online small team intervention training in which seven volunteer mediators trained to facilitate conflict in small work teams of no more than eight people per session.

New training opened the arena for state employees to explore new topics. The following guest presenters held sessions covering assorted topics throughout the fiscal year. The table below is a list of those trainings and does not include the volunteer mediators who volunteered their time.

Other trainings offered during FY23 included:

The ADR program maintains a volunteer pool of mediators who are state employees serving as neutrals in disputes referred from other agencies. Certified mediators serve the State of New Mexico in the cities in which they live and work.

Each year, the Bureau offers a formal 40-hour Mediator Certification course to ensure the state has a ready supply of knowledgeable and skilled mediation professionals. In FY23, the Bureau conducted a Mediator Certification course in Albuquerque certifying fifteen new mediators. Of those fifteen mediators twelve were certified in online mediation services. In FY23, the Bureau conducted its first in person mediator training since November 2019.

The ADR Bureau is the first line of defense to help mitigate workplace conflict. The goal of creating an environment where peers can work together on the overall missions of their agencies drives the need for the Bureau to be flexible to the needs of the evolving workplace culture.

Workers' Compensation Bureau

Workers' Compensation Bureau (WCB) fulfills RMD's statutory obligation to administer the Workers' Compensation Retention Fund and effect prompt and fair payment of workers compensation claims brought by state employees and employees of covered educational entities or local public bodies in accordance with the Workers Compensation Act, *see* NMSA 1978 §§ 51-1-1 *et seq.*, 15-7-6, and 52-1-3. WCB provides thorough and efficient claims administration of workers' compensation claims. WCB contracts services from case managers, investigators, and attorneys to meet the Workers' Compensation Act's statutory obligations, while also protecting the solvency of the Workers Compensation Retention Fund. The State is obligated to pay for all reasonable, necessary, and causally related medical care from alleged occupational injuries occurring during the course and scope of employment and provides an early return to work program that can reduce the average number of weeks a worker is absent because of an injury which can potentially increase employer savings.

The WCA has its own Administrative Court to resolve disputed cases through its Adjudication Bureau. A complaint can be filed at any time for a variety of reasons which initiates the dispute resolution process. At that point, a mediation hearing is then scheduled for all involved parties. Most worker's compensation disputes are resolved through mediation. Per statute, attorney's fees for both sides are capped at \$22,500.

A summary of key data associated with the top eleven agencies with claims is reflected in the table below. A quick review of those agencies shows there are wide disparities in key metrics impacting workers compensation exposure: organizational structure, budgetary capacity, and the nature of the occupation. Each of these metrics provides information that can be utilized by an agency to undertake methodologies to prevent and mitigate losses.

Employee Benefits Bureau

Under the Group Benefits Act, RMD is responsible for administering the self-insured group benefits plan ("Plan") offered to state employees and participating Local Public Bodies (LPBs), see NMSA 1978, § 10-7B-6. RMD's Employee Benefits Bureau ("EBB") coordinates and oversees the State of New Mexico's portion of the benefits plan("Plan").

With approximately 58,000 members enrolled statewide for medical, 63,000 in dental, and 53,000 in vision, the State's benefits plan is one of the largest self-insured plans in the state. The group benefits plan offers an Employee Assistance Program ("EAP"), medical, dental, vision, employer paid term life insurance with employee options for supplemental coverage, short- and long-term disability, a Flexible Spending Account Program ("FSA") for health care, dependent care, transportation/parking, and COBRA coverage. EBB continues to provide extra Supplementary Voluntary Benefits to its members (Cancer, Critical Illness, Whole Life, Long Term Care, and Accident).

The Plan continues to face the challenges of managing the rising costs of medical services and prescription drugs. The plan struggled to remain solvent during the pandemic, absorbing approximately \$60 million in COVID-19 costs from 2020 to date.

In the 2023 Legislative Session, Governor Lujan-Grisham enacted the Health Care transferring the management of EBB to the Health Care Authority (HCA) in FY25.. RMD has been working closely with the HCA on facilitating the transition. GSD is working closely with the DFA to reduce the existing deficit to zero and making the fund solvent prior to transition to HCA.

EBB introduced wellness programs such as preventive care, digital physical therapy, weight management and biometric screening. The Employee Assistance Program offers counseling services, financial wellbeing support, and legal support. The primary focus of EAP is behavioral health referrals. EAP offers many topics for webinars that focus on providing day-to-day support for many life situations. Medical carriers have implemented various health education webinars, health and wellness challenges and cooking shows for better health and wellness. The Stay Well Health Center (SWHC) in the Joseph M. Montoya building in Santa Fe, hired a patient advocate who collaborates with Carrier Preventive Care teams to enhance overall patient health.

Legal Bureau

The Legal Bureau provides strategic interagency management and coordination in all civil cases covered by the liability fund that have developed into complex State and Federal litigation or have a high likelihood of doing so. These claims include State and Federal Civil Rights Claims, Employment Claims, Class Action Claims, Inspection of Public Records Act Claims, Ethics Commission Complaints and Tort Claims involving great bodily harm, Child Abuse, and Wrongful Death. The Legal Bureau directly supervises and manages, currently, forty-four contracted civil defense firms throughout the State. The Legal Bureau is responsible, in collaboration with covered State agencies, for all strategic decisions during litigation including trial tactics, motions and appellate practice, and final determinations on taking cases to trial or reaching settlement. The Legal Bureau provides specialized expertise in settlement negotiations and mediations with the aim of reaching the best possible settlement deals balancing fiduciary duties with agency interests on behalf of the State in cases determined to be appropriate for settlement.

The Legal Bureau provides consultation and assistance to all covered State agencies on legal issues relevant to coverage and works closely with contract civil defense firms to remain appraised as to State and Federal legal developments that impact civil liability. The Legal Bureau is composed of experienced attorneys and Law Clerks with specialized skills. In 2022, the Legal Bureau was proud of having managed the litigation team, while working closely with DOH, in resolving the highly expensive, nearly 35-year-old Jackson et al., Consent Decree Case with an outcome that improved health care services for New Mexicans and saved millions in previously open-ended expenses.

Property & Casualty Bureau

The Property & Casualty Bureau ("PAC") effectuates RMD's statutory obligation to manage claims filed against the State of New Mexico and its insured entities, *see* NMSA 1978, § 15-7-2. Such claims include tort liability, personal injury, employment, civil rights, and other claims against the State of New Mexico, state entities, and public employees.

The PAC Bureau has a team of NM licensed adjusters who manage non-litigated claims and collaborates directly with claimants and insurers. This work includes claims involving vehicular damage, property damage, general liability, and other claims not anticipated to involve prolonged litigation. The PAC Bureau is tasked with evaluating and adjusting such claims and making liability and property payments in accordance with the Letter of Administration, coverage documents and the Tort Claims Act, NMSA 1978, § 41-4-1 through 41-4-30.

The Process: The PAC and Legal Bureaus analyze trends in settlement and litigation data to evaluate and strategically resolve claims. The risks involved with claims handled by the PAC and Legal Bureaus are usually presented as financial liabilities arising from covered occurrences. To evaluate the risk involved in a single claim, it is necessary to analyze the specifics of a claim within the greater legal landscape. By using institutional knowledge and historical data, claims can be properly appraised, saving Public Liability Fund expenditures. Also, the Legal Bureau utilizes a Litigation Risk Analysis ("LRA") for each case it settles. Each LRA compares the projected cost of defending a case against the cost of settling the case and the projected probabilities of various outcomes. This analysis allows the Legal Bureau to strategically resolve cases to preserve the Public Liability Fund.

The PAC Bureau typically oversees losses that involve quantifiable damages, the Legal

Bureau frequently deals with demands beyond financial remunerations. In employment actions, for example, a plaintiff may seek reinstatement in addition to financial payment. In these cases, Legal Bureau attorneys work with agencies to come to agreeable settlements that may have unquantified value. Over the years reported, liability and civil rights losses have continued to increase in frequency and severity.

In addition to liability payments, the PAC Bureau is also responsible for administering claims against the Public Property Reserve Fund, which protects "public buildings" of state agencies against loss or damage from fire, windstorm, hail, smoke, explosion, riot, or civil commotion as required by § 13-5-1. Section 13-1-5(B) which requires that RMD cover certain claims for agency losses of real and business personal property.



Loss Trends: Chart below reflects claims filed for each claim type:

Statutory Claim Payment Disclosure

Each year, RMD discloses indemnity payments over \$1,000.00 issued from the Public Liability Fund in its Annual Report per NMSA §15-7-3 (C). Since this report is a public document, RMD must comply with the confidentiality provisions of NMSA § 15-7-9 when disclosing claims payments data. This statute protects fund solvency while still allowing for transparent reporting of the use of taxpayer dollars.

Under NMSA §15-7-9, information about a claim may be released after a statutorily specified date of disclosure on and after:

- (a) the date a final judgment is issued resolving the claim and all appeals and rights to appeal have been exhausted; or
- (b) the date a settlement agreement is signed by all the parties.

In compiling this disclosure, RMD completed a thorough database search of all claims paid in Fiscal Year 2023 in accordance with NMSA §§ 15-7-9(A)(2)(c) and 15-7-9(A)(2)(d).
